Appropriate funds for the disposition of real property at The Groves at Loma

Linda

RECOMMENDATION

It is recommended that the City Council appropriate \$250,000.00 from Fund Balance to 01-1940-1830 (Contractual Agreements) to pay for consulting service related to the disposition of approximately 70.8 acres of property in The Groves at Loam Linda.

BACKGROUND

The above referenced property was previously owned by the former Loma Linda Redevelopment Agency and, in connection with the dissolution of redevelopment agencies in California, became the property of the Successor Agency. As required by dissolution law, and consistent with the long rang property management plan ("LRPMP") as previously approved by the Successor Agency, the Oversight Board, and the California Department of Finance ("DOF"), the Property will be disposed of by the Successor Agency upon close of escrow prior to December 31, 2020. Council has previously approved an agreement for consulting services with Land Advisors Organization (LAO) relating to the disposition of the subject Property on August 8, 2019. This action is for appropriation of funds relating to said agreement.

ANALYSIS

LAO worked with Staff throughout the planning process for the Groves at Loam Linda, and is highly familiar with the development criteria and property characteristics. LAO has been integral to the facilitation, purchaser selection, vetting of purchaser capabilities, and concluding negotiations relating to the sale of the property. The sale is scheduled to close prior to December 31, 2020.

ENVIRONMENTAL

This is a sale of real property and is exempt from CEQA. Environment issues raised through the development process will be addressed through that mechanism.

FINANCIAL IMPACT

In exchange for the services outlined in the agreement, payment is a Flat Fee of \$250,000, to be paid paid upon the successful sale of the Property. Funds to be appropriated from Fund Balance to 01-1940-1830 (Contractual Agreements)
